Delaware River Watershed Forum: Clean Water is Good for Business!

The Coalition for the Delaware River Watershed hosted its 11th annual Delaware River Watershed Forum in September, where members of the Clean Water is Good for Business Steering Committee collaborated with more than 300 watershed stakeholders, tackling issues of environmental preservation and economic development across the region.

The Sustainable Business Network of Greater Philadelphia led participants on a field trip to two green stormwater infrastructure (GSI) sites; both sites were partnerships between the Wilmington Department of Public Works and

community organizations. The first site, <u>Cool Spring Park Eco-Trail and</u> <u>Playground</u>, utilizes rain gardens, meadows, and reservoir buffers to manage stormwater, enrich green spaces, and store excess drinking water. The second site serves as a cultural and performance center while also addressing the overflow from the combined sewer system. Participants learned that through creative partnerships, cities can leverage state funds to create thriving community spaces that also protect our watersheds.

SBN Philadelphia also led a round table discussion among regional businesses working towards clean water. The panelists shared valuable resources for doing business in Delaware, and learned best practices for advancing the triple bottom line – people, planet, and profit – in their business.

State and Regional Updates

Clean Water in the Delaware River Basin Depends on Sustainable Funding

The Delaware River Basin Commission (DRBC) is a small agency with a big impact. Established in 1961, the DRBC is the first river basin planning, development, and regulatory agency where the federal government and states are equal partners, serving the 14 million people who depend on the basin for drinking, agriculture, business, and industrial use. DRBC protects the watershed through water quality, project review, and flood and drought management, while building partnerships with a range of regional stakeholders.



From its headwaters in New York State to the Delaware Bay, the Delaware River Basin supports the water needs of roughly 4% of the U.S. population, and drives a \$20 billion water-based economy that supports 600,000 jobs. **Despite its critical role supporting clean water in the basin, DRBC's funding is not reliable** – the agency must work to secure state and federal funding *each year*. In recent years, New Jersey and Delaware have fully funded their share of the DRBC budget, but Pennsylvania and New York have provided only part of their share. Despite Congressional authorization, the federal government has failed to fund the agency for 23 of the last 25 years.

Take Action to Protect Soil and Water Health in Pennsylvania



The Pennsylvania State Conservation Commission announced FOUR years of dedicated funding to activate the state Sustainable Agriculture Board and develop a statewide soil health program. This is a big win for soil health as well as the state's natural resources, economy, and farming sector. However, changing soil health takes time – state policymakers **must make this funding permanent**, so that our state will continue to strengthen our economy and reduce agricultural pollution for the next generation.

The Clean Water is Good for Business Steering Committee is sending a letter to Pennsylvania policymakers, urging them to make this funding permanent.

Take Action in New York

The New York State Legislature passed the <u>Birds and Bees Protection Act</u>, a first-in-the-nation bill that would limit the use of neurotoxic neonicotinoid pesticides ("neonics"), which persist in soil and are easily carried long distances by rain or irrigation water. The bill will protect pollinators and the farmers who depend on them, while also safeguarding New York's economy. **However, Gov. Hochul has not yet signed this bill into law, and must do so by the end of 2023 in order for the law to take effect.**

Take Action: Please call Gov. Hochul at 518-474-8390, press 2 to speak to a person. (If you are left on hold you can press 1 to leave a message.)

SAMPLE SCRIPT: "Hello, my name is _____ and I live in _____. I'm calling to urge Gov. Hochul to sign the Birds and the Bees Protection Act (S1856-A Hoylman-Sigal/A7640 Glick), which would curb wasteful use of neurotoxic neonic (knee-OH-nick) pesticides that cause mass losses of bees and other pollinators we depend on for food. These chemicals also extensively pollute our water, risking our health as well as the jobs and businesses that depend on clean water. I strongly urge Gov. Hochul to sign this bill into law today."


<u>National Story</u> ASBN Advocates For Federal Clean Water Protections



As we celebrate the 51st anniversary of the Clean Water Act, the future of our nation's water supply is still under threat. Congressional leaders recently invited Colton Fagundes, ASBN's Policy Director for Regenerative Agriculture and Clean Water, to testify at a House hearing called, "Murky Waters: Navigating a Post-Sackett World."

Colton testified that clean water benefits both the environment and the prosperity of our businesses and communities. He noted that industries such as beverage manufacturing, seafood, outdoor recreation, and agriculture are directly dependent on clean water, but any weakening of the Clean Water Act will hurt businesses across the economy. Following the hearing, Congress introduced the Clean Water Act of 2023 which begins to restore some of the water protections that were lost in the Supreme Court's *Sackett* decision.
